

History

The history we are taught in school and by many of the history books is sanitized. It is the story of the “victors” and especially of the ruling elite who need to spin events in a favourable light. After all, 16 million people died in WW1 and civilian and military casualties are estimated at 37 million. It would be shocking to blame such monstrous carnage on the ambition of a ruling elite and their lust for power, much more noble reasons must be sought. WW1 is the key event because it was the first “global” war and in the predictive words of one observer the twenty years of peace after the Versailles treaty was really only an “armistice” allowing the combatants time to replace the lost generations with more

young blood; preparing the meat for the meat grinder of the second round (WW2). Moreover, the end of this era saw the rise of Communism, the Central Bank (Federal Reserve) in the USA and the Balfour declaration. All these events are linked and are determinative for how our current century is shaped. Anyone who attempts to understand these events outside the defined narrative is labelled a “conspiracy theorist” because it is dangerous to question received wisdom. We are being propagandized and herded to our destruction with war after war ushering us closer to a global utopia envisaged by the privileged few. Some men (such as George Orwell) understood this and they painted a bleak authoritarian future.

Social Drivers

The hundred years between 1800 and 1900 were ones of enormous change. However, the commencement of this age needs to be understood against the cataclysmic events that went before. Perhaps the best “feeling” for this age can be obtained through the first words of Charles Dickens novel “A Tale of two Cities” published in 1859 but set in the cities of London, England, and Paris, France during the time period of 1775-1790. Some of the events of the French Revolution, which began in 1789, are recreated in the novel and are central to its plot:

“It was the best of times, it was the worst of times, it was the age of wisdom, it was the age of foolishness, it was the epoch of belief, it was the epoch of incredulity, it was the season of Light, it was the season of Darkness, it was the spring of hope, it was the winter of despair, we had everything before us, we had nothing before us, we were all going direct to Heaven, we were all going direct the other way – in short, the period was so far like the present period, that some of its noisiest authorities insisted on its being received, for good or for evil, in the superlative degree of comparison only”.

This gives the essence of the times. It was all in play... everything to win and everything to lose. A time of immense upheaval; the historical books would summarise as follows;

The French Revolution was a period of far-reaching social and political upheaval in France and its colonies beginning in 1789. The Revolution overthrew the monarchy, established a republic, catalysed violent periods of political turmoil, and finally culminated in a dictatorship under Napoleon who brought many of its principles to areas he conquered in Western Europe and beyond. Inspired by liberal and radical ideas, the Revolution profoundly altered the course of modern history, triggering the global decline of absolute monarchies while replacing them with republics and liberal democracies.

The next century (1800-1900) was therefore a century of struggle between the “Old Europe” and the “New Europe”. After the Napoleonic revolution the Kings and Queens of the various Monarchies attempted to resist the tide of self-determination and turn back the clock. But that never works, the genie was out the bottle and people saw new possibilities for organizing themselves. However, for a time after the French Revolution the Kings and Queens imposed their will and nations were divided up as personal fiefdoms along arbitrary lines. How (for example) can a nation continue without problems which is half French speaking and half German speaking or part Serbian and Austrian etc? This silly division of ethnicities was bound to give rise to nationalism and that is exactly what happened.

We use the term “Europe”, but Europe was a global phenomenon as she possessed colonies all over the world held by countries like Britain, Holland, France and Spain etc. These European countries possessed global “properties” and they were ruled by Kings and Queens. However, once these Kings and Queens were deposed and removed who would take their place? Who would rule? Various ideas floated around during the century that followed - liberal democracy, communism, nationalism, socialism or some combination? Who would rule in the absence of Kings and Queens? Would some form of people power rule instead of monarchy?

However, even without “revolution” Kings and Queens would have become an anachronism. Why is that? Because the old aristocracy with their landed wealth based on feudalism was being replaced by an emerging aristocracy. The “new money power” was based on the industrial revolution.

The Industrial Revolution, now also known as the First Industrial Revolution, was the transition to new manufacturing processes in Europe and the United States, in the period from about 1760 to sometime between 1820 and 1840. Most important, however, 19th-century Britain experienced political unrest as the industrialization and urbanization of the country created a need for social and political change. There were increasing demands for improved social welfare, education, labour rights, political rights and equality, as well as for the abolition of the slave trade and changes in the electoral system.

The Industrial Revolution brought fundamental changes in the British way of life. Scientific innovations and technological improvements

contributed to the advancement of agriculture, industry, shipping and trade and to the expansion of the economy. With the increase of capital and the need for credit, banking developed not only in London but also in the countryside. Industrialists, shipbuilders, merchants and other private manufacturers established provincial banks and issued paper money in the form of bills of exchange and notes, primarily in order to provide payment for labour and for the purchase of raw materials.

Super rich merchants and industrialists were emerging – building factories for textiles etc. People were moving from the countryside and from farming aristocratic estates etc to the cities looking for work. Of course, this rapid urbanization brought its own problems – sanitation, crowding, exploitation etc but those problems were gradually solved (to an extent). The important point is that a new ruling class emerged, and that class was funded by the same bankers who had funded the wars of the Kings and Queens and then funded the revolutions. For, example, the Kings and Queens and their wars were funded by the Rothschild family (who were court bankers and Vatican bankers) but they also funded the Napoleonic war that overthrew the Monarchy and subsequently they funded the “new royalty” of industrialists (Cecil Rhodes and his company De Beers) and they funded the policy of the “shadow government” (the Russo-Japanese war) to expand empire (more on this anon) as well as the communist revolution. Money has no allegiance, but the dispensers of money had their own agenda that piggy-backed comfortably on the schemes and plans of grandiose European dreams of global empire. Does a behemoth notice a tick along for the ride? Only when the behemoth is dying does he notice that the tick that he carried around is engorged with blood.

The problem was that industrialisation upset the applecart, but it offered new opportunities because change always has winners and losers. The Kings and Queens were the losers. The bankers and industrialists were the winners. But countries stood to lose as well. Britain was the first to industrialize and had a huge empire, but Germany was emerging very fast as a superpower. All the little German “mini states” and principalities were uniting and starting to make “good stuff”. Think here of America and the rise of China. Germany was therefore seen as a threat to Anglo-Saxon hegemony. Germany must be stopped and not allowed to develop. It was that simple. However, mixed in with this is the story of the Jews who were treated atrociously in Eastern Europe and Russia, but Jews were treated well in Germany before WW1.

We will discover that global war is driven by competing needs for global hegemony. The Anglo-Saxon model was based on the British Empire of Queen Victoria, but it was the attempt by industrialist-merchants like Rhodes *et al* to expand that empire even further that precipitated WW1. Later, under Hitler, the Germans would attempt their version of

globalism bearing quasi religious overtones with the establishment of a thousand year "Reich". However, hidden from view amongst these greater movements was the Zionists desire to establish their homeland, ostensibly as a refuge from anti-Semitism but, although Zionism was a secular nationalist project, it also carried religious overtones of their manifest destiny to rule all nations from Zion.

All these peoples represented competing ideologies that rested on the superiority of their race, namely, the Anglo-Saxon race, the Aryan race or the Jewish race. In some ways they all saw their race as superior in language, culture, religion and virtue and therefore fit to rule the world and fulfil their manifest destinies. In opposition to movements based on racial or national superiority we had the communists who although at heart a Jewish movement rejected race and religion altogether and (supposedly) espoused an international "brotherhood" based on equality and ownership of the means of production (replacing God with the state). At heart they are all global ideologies. Therefore, globalism is not something that has appeared out of nowhere. Moreover, bankers played and still play a prominent role in all these ideologies and in the wars (even before industrialisation) that they caused because in the end money is power. As the saying goes – follow the money. Pre-industrial feudalism has been replaced by the money power of the financial age which has made all of us debt slaves in preparation for the final push towards globalist control. It is still all up for grabs, but the field is narrowing.

The treatment of German Jews pre-WWI

What is remarkable is not the degree of intolerance, but the extent to which Jews were tolerated and even encouraged in Germany.¹ Jews were permitted to wield tremendous power and influence even though so many of them -- with the Warburgs at the forefront -- were part of a mighty, supra-national Jewish network that was dedicated above all to its own particular interests.²

The cause of the War

Most historians agree that the cause of war was a rather trivial dispute between Austria and Serbia. The assassination of the Austrian heir to the throne Archduke Franz Ferdinand and his wife Sophie by the Serbian nationalist Gavrilo Princip of the occult secret society “Black Hand” in Sarajevo sparked the First World War.

However, the creation of the German empire under Bismarck upset the “balance of powers” that had been existing in Europe for more than two centuries. England ruled supreme over the continent until 1871. This supremacy had been repeatedly challenged by Spain and by France, but England always remained victorious. The fact that Germany now grew stronger, by acquiring colonies and by building up its military force, was a severe threat to the ruling Anglo elite and its supremacy over Europe both economically and militarily.

To counteract this, the international bankers who at that time were to a large extent excluded from the economic development in Germany, sought for ways to limit and control Germany. Between 1894 and 1907 several international treaties were signed to have Russia, France, England and further nations unite against Germany in the case of war. It was the task of the oligarchs to set the stage for the First World War. A group emerged as a front the “Royal institute for International Affairs” (RIIA). It is also known as “Chatham House” and had among its founding members Lord Albert Grey, Lord Arnold Toynbee – eminence grise of the MI6, H.G. Wells, Lord Alfred Milner – head of this Round Table group, and H.J. Mackinder – inventor of the so-called geopolitics.

Lord Northcliff, Lord Rothmere and Lord Toynbee of the MI6 were involved. **Edward Bernays** and **Walter Lippmann** were American “specialists” attending. **Lord Rothmere** used his newspaper as a tool to try out their “social conditioning” techniques on his readers. After a test period of six months they had found that 87% of the public had formed opinions without rational or critical thought processes. That was what they wanted. Thereupon the English working class was subjected to sophisticated propaganda methods to convince them that they had to send their sons by the thousands to their deaths. In America, President Theodore Roosevelt, the 26th President, said during his election campaign in 1912:

“Behind the visible government there is an invisible government upon the throne that owes the people no loyalty and recognizes no responsibility. To destroy this invisible government, to undo the ungodly union between corrupt business and corrupt politics is the task of a statesman.”

(Dieter Ruggeberg: “Geheimpolitik”, p. 75)

The Russian Revolution³

Despite having the largest army in the world Russia was desperately under-equipped for any sizeable action. Before fighting started in 1914 the crown had promised Russia its full support and military help in the case of war. After the war had begun, that help was reduced to 10% of its pre-war level. Apparently, the financial monopolists wanted to force Russia into as dangerous a situation as possible.

At a time when millions of Russians had already died on the battlefields, the Rothchild's agents compounded the problems by their activities. Their endeavours to set the stage for a revolution following the German defeat, was successful.

The revolution started in February 1917 when the Czar was deposed and a provisional government under Prince Georgy Luvov took over. This government however failed to stave off the national decline. Trotsky and his rebels left New York on the SS-Kristianiafjord with 20 million US\$ in gold.

The boat – chartered by Jacob Schiff – was held up on April 3, 1917 by the Canadian authorities at Halifax, Nova Scotia. The plan seemed doomed. But Jacob Schiff and his powerful friends in the U.S. government and in England exerted their influence and soon the voyage could continue. After arrival in Europe Trotsky went to Switzerland to meet with Lenin, Stalin, Kaganovich and Litvinov and to co-ordinate their strategy.

Perhaps it is interesting to note here that the heads and agents of all the nations involved in the war could meet in neutral Switzerland. At the Congress of Vienna in 1815 – after Napoleon's defeat – Switzerland was restored. The confederation was guaranteed neutrality forever by the powers of Europe and that is no accident.

Now the conspirators faced the question of how to get the rebels and equipment from Switzerland to Russia. The answer was furnished by the Rothschild agent and industrialist chief of the German secret police Max Warburg. He had them all packed in a sealed railway carriage and made sure this passed safely through Germany to the Russian border. When the train stopped in Germany for the first time, two German officers got on to escort it. They had been commandeered by General Erich Ludendorff. Max Warburg was the brother of Paul Warburg, the first chairman of the "Federal Reserve Bank".

In July 1917 the conspiracy supported by the international bankers suffered a first setback and Lenin, a Khazar, had to flee with a few others to Finland. But in November 1917 they were finally successful.

And no wonder, if we look at the financial support that they had following their training in New York. During the bloody civil war that ensued after the Bolshevik Revolution, Lenin was the undisputed leader of political activities while Trotsky organized the military arm, the "Red Army". That name was not an accidental choice. The Bolshevik army under Trotsky was the deadly instrument of the international bankers controlled by the Rothschilds (= red shield). So, it was very befitting to have the army carry a red emblem. It is now an established historical fact that most of the rebels led by Lenin were Jews. The Times of March 29, 1919, wrote that,

"one of the most interesting features of the Bolshevik movement is the high percentage of non-Russians in the leadership. OF THE 30 OR SO COMMISSIONERS OF LEADERS THAT FORM THE CENTRAL APPARATUS OF THE BOLSHEVIK MOVEMENT, NO LESS THAN 75% ARE JEWS."

According to writings of General A. Nechvolodov the French secret service had found out that Jacob Schiff had directly supplied the Russian revolutionaries with a further 12 million US\$. Nechvolodov also name Felix Warburg, Otto Kahn, Mortimer Schiff, Jerome H. Hanauer and Max Breitung in the U.S. and Max Warburg, Olaf Aschburg and Jivtovshy in Europe as further financiers of the Bolshevik Revolution. The ambassador of the Russian Empire to the U.S., Bakhmetiev, declared that after the Bolshevik victory 600 million Rouble in gold was transferred from Russian to the Kuhn Loeb Bank in New York between 1918 and 1922.

The book "The Sealed Train" by Michael Pearson shows that – according to documents of the German Foreign Office – up to February 5, 1918 Germany had supplied 40,580,997

Marks for propaganda and “special requirements”. In the same document it is stated that the German treasury released 15 million Marks to Russia one day after Lenin seized power. The bloody massacre of millions of Russians and the enslavement of further millions was however of scant interest to the international bankers on their way to world dominance.

Of course, the Communist revolution unleashed a reign of terror in which millions died and this included the Holdomor in the Ukraine (1932-33). Holdomor is the Ukrainian word for “death by hunger” which led to cannibalism and the starvation of up to 7.5 million people. This was supposedly the result of “collectivizing” the farms and confiscating food in order to forcibly remove people.⁴ Apparently at least 30% (some say much higher) of the secret Soviet police (enforcers known as the NKVD) were Jews. It is often countered that Stalin deliberately “stacked” the organisation with Jews because they were “useful scapegoats” and it is also often said that the famine was not man-made but “natural” and the whole story is fascist propaganda to explain why so many Ukrainians became Nazis.

As Sever Plocker remarks, And us, the Jews? An Israeli student finishes high school without ever hearing the name "Genrikh Yagoda," the greatest Jewish murderer of the 20th Century, the GPU's deputy commander and the founder and commander of the NKVD. Yagoda diligently implemented Stalin's collectivization orders and is responsible for the deaths of at least 10 million people. His Jewish deputies established and managed the Gulag system. After Stalin no longer viewed him favorably, Yagoda was demoted and executed, and was replaced as chief hangman in 1936 by Yezhov, the "bloodthirsty dwarf." Yezhov was not Jewish but was blessed with an active Jewish wife. In his Book "Stalin: Court of the Red Star", Jewish historian Sebag Montefiore writes that during the darkest period of terror, when the Communist killing machine worked in full force, Stalin was surrounded by beautiful, young Jewish women.⁵

You must decide the truth for yourself, but Communism was started by Karl Marx (a Jew) the first revolutionary movement was 75% Jewish and the secret police was “stacked” with Jews (at least 30%) who carried out their tasks with great relish and cruelty. This is hardly “scapegoating”. This might explain why so many concentration camp guards during WWII were Ukrainian volunteers.

America dragged into the War

America did not want to enter the war and was “isolationist”. In fact, Woodrow Wilson fought (and won) his electoral campaign on not entering the war, yet less than a year later the USA was at war. The suggestion is that he was blackmailed into the war.⁶ Previously, Wilson had been pushed into supporting the Federal Reserve Act. This is important because in the end all wars are bankers’ wars. Nothing is as profitable as war. The profits are guaranteed by taxpayers, the losses are in blood (not the bankers) and treasure (not the bankers). It is therefore “win, win” with no downside (if you are a psychopath). A secret gathering at a secluded island (Jekyll Island) off the coast of Georgia in 1910 laid the foundations for the Federal Reserve System. In 1914, Edwin Seligman, a prominent professor at Columbia University, wrote that “in its fundamental features the Federal Reserve Act is the work of Mr. Warburg more than of any other man.” In 1927, Seligman and Glass debated this point in a series of letters published in the New York Times.⁷

When World War I broke out in Europe in 1914, Lindbergh was vocal that the United States should not become involved. In 1916 he lost his US Senate bid to an opponent who openly advocated American intervention in Europe. In Congress, Lindbergh was one of the first outspoken critics of the Federal Reserve. His stature grew when he was featured in an article in American Magazine: "It was a Swede from Minnesota who first raised in Congress the hue-and-cry of the Money Trust Hunt-'a Swede who dreams, 'a fellow member described him-Charles A. Lindbergh."⁸

Lindbergh declared, "This Act establishes the most gigantic trust on Earth. When the President signs this bill, the invisible government by the Monetary Power will be legalized, the people may not know it immediately, but the day of reckoning is only a few years removed.... The worst legislative crime of the ages is perpetrated by this banking bill." ⁹ In 1917 Lindbergh brought articles of impeachment against members of the Federal Reserve Board including Paul Warburg and William Proctor Gould Harding, charging that they were involved "...in a conspiracy to violate the Constitution and laws of the United States..." ¹⁰ Why is this so important? Because it was the money power (bankers) that got the USA into the war. Germany and Brittan had fought each other to a stand still and eventually they

would have negotiated a peace (in fact they had already started). It was the promise of guaranteeing American involvement in the war and of funding that allowed the Rothschild bankers gain the Balfour Declaration as a *quid pro-quo*. And so, every effort was made to show that the Germans were monsters, including the false flag attack on the Lusitania passenger ship transporting munitions and the false flag “Zimmerman” telegram.¹¹

The Aftermath of WWI

Four empires disappeared during the First World War – the German Reich, the Austro-Hungarian Empire, the Tsarist Holy Russian Empire, and the Ottoman Sublime Porte. The victors utterly lacked any sense of reason in the conditions they imposed on the defeated. Thus, in Europe, the Treaty of Versailles determined conditions which were unacceptable and unbearable for Germany, **falsely blamed as the sole responsible for the conflict**. In the Orient, the carving up of the Ottoman Caliphate was not going well. At the San Remo Conference (1920), in accordance with the secret Sykes-Picot agreements (1916), the United Kingdom was authorised to set up a Jewish homeland in Palestine, while France was allowed to colonise Syria (which included, at the time, what is now Lebanon). However, in what was left of the Ottoman Empire, Mustafa Kemal led a revolt both against the Sultan, who had lost the war, and against the Western powers, who were taking control of his country. At the Sèvres Conference (1920), the Caliphate was chopped into little pieces in order to create a variety of new states, including a Kurdistan. The Turko-Mongol population of the provinces of Thrace and Anatolia rose up and carried Kemal to power. Finally, the Lausanne Conference (1923) traced the frontiers we know today, gave up on the idea of Kurdistan, and organised gigantic population transfers which caused more than half a million deaths.¹²

This was also the time of the Armenian genocide (1914-1923) the consequence of the Turkish Revolution and the “Young Turks”. Author Hans-Lukas Kieser says a desperate Zionist press praised the empire even during the slaughter of its minority population, a murder which Israel continues to gloss over today. As the Times of Israel reports; “Before the Holocaust, Ottoman Jews supported the Armenian genocide’s ‘architect’”.¹³ The Jews of the Ottoman Empire, unlike its other minority communities, did not have separatist tendencies, and as a result developed a special relationship with the radical Young Turks

after the revolution of July 1908.¹⁴ Indeed, this period contains enough to satisfy any “conspiracy theorist”. Reputable studies show complicity and involvement between “Young Turks”, “Free Masons” and “Jews”, the whole lot!¹⁵ Kemal Atatürk (Mustafa) the president of the newly formed Turkish Republic was accused of being a Dönme. The Dönme (Turkish: Dönme) were a group of crypto-Sabbateans (commonly referred to as crypto-Jews) in the Ottoman Empire who converted publicly to Islam but were said to have retained their beliefs. This may well have been a slur by Islamists who did not like his reforms, nevertheless, there were some close connections between the Jews and the Young Turks as even the Jewish newspapers are starting to recognize. About 1.5 million Armenian Christians were murdered some being burnt and women raped and crucified. The world did nothing about it and the Armenians have been fighting for decades for recognition of the crime as genocide and for reparations.

This was all grist to the mill, for when Hitler came to power, he blamed the Jews for betraying Germany. He had fought and been decorated during WWI and knew of the Armenian genocide¹⁶ and he was aware of the Holodomor. In 1919, Erich Ludendorff, one of Germany’s top military leaders, announced that Jews were one of several groups responsible for the nation’s defeat. By 1922, he was focusing almost entirely on Jews as “the enemy.” He wrote, “The supreme government of the Jewish people was working hand in hand with France and England. Perhaps it was leading them both.” As proof, he cited the *Protocols of the Elders of Zion*, a document supposedly containing the minutes of a secret meeting of Jewish leaders—the so-called “Elders of Zion”—held at the turn of the twentieth century. At that supposed meeting, the “Elders” allegedly plotted to take over the world. In fact, the *Protocols* is a forgery; Russian secret police wrote it in the early 1900s to incite hatred against Jews.¹⁷ That said, forgery or not, two earlier books, admittedly written by disenfranchised Jews (who converted to Christianity), made similar claims.

When Hitler came to power, Germany was hopelessly broke. The Treaty of Versailles had imposed crushing reparations on the German people, demanding that Germans repay every

nation's costs of the war. These costs totalled three times the value of all the property in Germany.¹⁸ Economist Henry C K Liu writes of Germany's remarkable transformation:

"The Nazis came to power in 1933 when the German economy was in total collapse, with ruinous war-reparation obligations and zero prospects for foreign investment or credit. Through an independent monetary policy of sovereign credit and a full-employment public-works program, the Third Reich was able to turn a bankrupt Germany, stripped of overseas colonies, into the strongest economy in Europe within four years, even before armament spending began." (Henry C. K. Liu, "Nazism and the German Economic Miracle," Asia Times (May 24, 2005).

In *Billions for the Bankers, Debts for the People* (1984), Sheldon Emry commented:

"Germany issued debt-free and interest-free money from 1935 on, which accounts for Germany's startling rise from the depression to a world power in five years. The German government financed its entire operations from 1935 to 1945 without gold, and without debt. It took the entire Capitalist and Communist world to destroy the German revolution and bring Europe back under the heel of the Bankers."

Of course, the "bankers" wanted this disease (countries controlling their own financial destiny) to be stopped before it spread to other countries.

According to Netanyahu, Hitler did not want to exterminate the Jews, it was the Mufti who put him up to it! ¹⁹ Of course, that is ridiculous, but one can imagine that the Grand Mufti wanted to stop the Jews gaining a further toehold in Palestine and Hitler was afraid of "Jewish Communists" in Russia and "Jewish bankers" turning Germans into debt slaves. Germany had lost its trust in Jews in WWI and underwent its own short-lived revolt (the *Spartacist uprising* in 1919) led by Communist Jews. Therefore, Germany felt threatened,

they had treated the Jews well and had been betrayed – they would not make the same mistake again.

As for the current obsession with Political Correctness and Multiculturalism etc is none other than Cultural Marxism promoted by the Frankfurt School who were expelled from Germany (or fled Hitler) in the 1930's, whose lecturers ended up in Western universities particularly in California. This is a Jewish movement that has successfully fragmented society by introducing and normalising depravity and division. The kind of liberalism (open borders, gay marriage., etc) that would never be accepted by religious Orthodox Jews, but it is perfectly OK for gentiles to adopt these practices. This is based on Jewish supremacist thinking – they will remain pure and rule over a gentile rabble (who are, truth be told, no better than animals anyway, so the Talmud).

Conclusion

Some elements of this period have been glossed over because they are so “sensitive” that one can hardly question or examine them. There is always some truth to be found in propaganda, but it is a question of degree. Facts, get distorted, they are “spun” and de-contextualized. You must do your own digging and your own research and make up your own mind. Often historical truth is the middle way between two extremes. One thing is certain.... you have not been told the historical truth and will not find it in the “approved” educational history books. For reasons of brevity we have only just scratched the surface. The lies are only just starting to unravel because of the internet and that will not be allowed to continue for much longer.

Summary

The First World War was a struggle for world dominance between the UK and Germany. The Germans were deliberately destroyed, and such onerous terms were placed on them at the treaty of Versailles that it would inevitably lead to WW2.

The Anglo-Sphere – Britain and her colonies won the day. America has since emerged as the global Empire.

Some of the main characters

Jacob Henry Schiff (born Jakob Heinrich Schiff; January 10, 1847 – September 25, 1920) was a Jewish American banker, businessman, and philanthropist. Among many other things, he helped finance the expansion of American railroads and the Japanese military efforts against Tsarist Russia in the Russo-Japanese War. Born in Frankfurt, Germany, Schiff migrated to the United States after the American Civil War and joined the firm Kuhn, Loeb & Co. From his base on Wall Street, he was the foremost Jewish leader from 1880 to 1920 in what later became known as the "Schiff era", grappling with all major Jewish issues and problems of the day, including the plight of Russian Jews under the Tsar, American and international anti-Semitism, care of needy Jewish immigrants, and the rise of Zionism. He also became a director of many important corporations, including the National City Bank of New York, Equitable Life Assurance Society, Wells Fargo & Company, and the Union Pacific Railroad. In many of his interests he was associated with E. H. Harriman. Schiff was born in 1847 in Frankfurt am Main, Germany, to Moses and Clara (née Niederhofheim) Schiff, members of a distinguished Ashkenazi Jewish rabbinical family that traced its lineage in Frankfurt back to 1370. His father, Moses Schiff, was a broker for the Rothschilds.+++++

Bernard Baruch was born to a Jewish family: War Industries board. In 1916, Baruch left Wall Street to advise President Woodrow Wilson on national defence. The War Industries Board (WIB) was a United States government agency established on July 28, 1917, during World War I, to coordinate the purchase of war supplies between the Army and the Navy.+++++

Samuel Prescott Bush great grandfather of George Bush. In the spring of 1918, banker Bernard Baruch was asked to reorganize the War Industries Board as the U.S. prepared to enter World War I, and placed several prominent businessmen to key posts. Bush became chief of the Ordnance, Small Arms, and Ammunition Section, with national responsibility for government assistance to and relations with munitions companies+++++

Cecil Rhodes whose primary motivations in politics and business was his professed belief that the Anglo-Saxon race was, to quote his will, "the first race in the world". Under the reasoning that "the more of the world we inhabit the better it is for the human race", he advocated vigorous settler colonialism and ultimately a reformation of the British Empire so that each component would be self-governing and represented in a single parliament in

London. Rhodes was named the chairman of De Beers at the company's founding in 1888. De Beers was established with funding from N M Rothschild & Sons Limited in 1887.+++++

Max Warburg, who was their leading Jewish banker in Germany, and reputedly head of the German espionage system during the war, also played a major role in financing both Lenin and Trotsky and enabling the 'sealed train' journey across Germany. Fritz Warburg was in Stockholm during the war as coordinator of major financial transactions between Germany and the Bolsheviks, and according to British intelligence reports he also had close contact with the notorious Parvus. When the Warburg bank in Hamburg was about to collapse in 1857, the Rothschilds injected vast amounts of money into it. The Warburg brothers, who have featured heavily in every aspect of war loans and financing, acted as covert agents of Rothschild. +++++

Paul Warburg, a prominent New York Jew brother of Max Warburg (in Germany) and the leading agent who fronted the drive to establish the Federal Reserve System for the Secret Elite. Paul was senior partner with Jacob Schiff in Kuhn, Loeb & Co. Bank which was effectively a Rothschild front. The Schiff and Rothschild forebears had actually lived in houses in the same building they shared in the Jewish ghetto in Frankfurt am Main, and Jacob Schiff was yet another Rothschild agent. The American authorities clearly believed that he and his powerful banking associates were deeply implicated in the Russian revolution.
